If this ballot is pre-marked, please discard it and submit a ballot marked only by you.** If you do not have a blank ballot, you may obtain one by calling USA Triathlon at 719/597-9090. To ensure legibility, please mark your ballot in dark ink.

**TO RE-CAP, NO CANDIDATE IS ALLOWED TO:** disseminate a ballot to any voter that has been pre-marked in any fashion; contact the USAT national office staff for purposes of obtaining a membership number or any other information that is absent from a ballot; submit a ballot that has any crossed-out vote and an associated vote in support of another candidate or complete any portion of the ballot left blank by a voter; submit a ballot of an athlete who has an expired membership before the November 1 cutoff.
